<p>Bidders must sign and include the applicable NON-COLLUSION, DEBARMENT AND GIFT BAN CERTIFICATION form(s) found on pages SSP-55 through SSP-60 of the Contract Proposal.</p>
<p>Bidders must sign and include all applicable BID BOND, CONTRACT PAYMENT BOND, CONTRACT PERFORMANCE BOND, AND FURTHER AGREEMENTS form(s) found on pages SSP-69 through SSP-94 of the Contract Proposal.</p>
<p>In addition, please see Special Provision for FUEL PRICE ADJUSTMENT which was added as part of Addendum #3. Per this Special Provision, the bidder may include the Fuel Usage Factor Adjustment Form with their bid submission if they elect to use the fuel usage factor. A link to the form is included in the Special Provision.</p>
