Permitting

Activity

The Town of Rolesville issued eighteen single-family dwelling permits in July 2019. In July 2018, the Town issued 1. Barrington, Carlton Pointe, Granite Falls, Perry Farms, Stonewater, and Willoughby subdivisions received building permits in July. The Town also twelve Certificates of Occupancy for single-family homes for June. The Town of Rolesville has experienced a decline in permitting activity since January 2019. From January 2018 to July 2018, the Town issued 124 permits. During that corresponding period in 2019, the Town issued 86 permits, a 30.6% decrease so far this calendar year.

There are significant developments in the review process that will have a large number of units. These developments could increase permitting activity in coming months.
