Annexation (Voluntary)/ Development Agreement/ Rezoning (Map Amendment)/ Text Amendment

*Annexation requests skip the Planning Board, going directly to the Town Board. Step 1) Call for the Town Clerk to investigate sufficiency; Step 2) Call for a Legislative Hearing; Step 3) The Town Board Conducts a Legislative Hearing. When Annexation requests accompany a Rezoning, steps 2 and 3 follow the Rezoning process in most instances.

The above rows represent a "Cycle". Each row represents the best-case scenario of achieving "No comments or No further comments" and moving to the required next meeting. A first Submittal Application with "No comment" may theoretically move through this process, start to finish, in just over three (3) months, or approximately thirteen (13) weeks. If the applicant resubmits for the next possible cycle, each additional cycle of review adds 2 two months (8-9 weeks).
