- 6. UDO TA 21-04 Land Development Ordinance: Ms. Spriggs introduced Mr. Keppler and Mr. Ehrmann, Kimley Horn consultants who reviewed the slides they had prepared with the proposed LDO draft.
  - Town resident Mr. Jimmie Sanders 600 Longmelford, Drive Rolesville questioned if a ban on certain trees could be added to the LDO? Mr. Keppler replied a ban is not included on specific species, however, a landscape design plan must be approved by staff, and staff must also follow the list of acceptable plants and trees per the NC Forest Service.
- 7. MA 21-04 Zoning Map: Mr. Klepper and Mr. Ehrmann, Kimley Horn consultants reviewed the slides they had prepared with the proposed Zoning Map. They pointed out the zoning map will only change the names of the districts, there will be no other changes.

Board Member Lawrence made a motion to recommend approval of UDO TA 21-04 to the Board of Commissioners the Planning Board concludes the proposed amendment is reasonable and in the public interest because it brings local ordinances into compliance with the applicable North Carolina law. Additionally, the proposed amendment supports the following policies and goals in the town's adopted comprehensive plan goals LU1, LU2, LU3, and LU5. The zoning amendment MA 21-04 will also be added and accepted as part of this motion. Second by Board Member Pearce, carried by unanimous vote.
