Please provide additional contour labels (example, around SCM 4). Grades shown do not match DA map. 4. All SCMs should have at least 10 ft flat perimeter that is off the slope and within the easement. 5. Please provide top and bottom elevations of retaining walls. 6. Label existing dam with ID number from NC Dam Safety. If dam is not on inventory, obtain jurisdictional determination from NC Dam Safety. 7. *The CD plans may be formally submitted to Wake Co. through Permit Portal for review of Sediment and Erosion Control (SEC) & Stormwater Management Plan (SWF) permits; those reviews will result in more detailed additional comments. <u>Permitting should be done by phase – One SEC/SWF permit per phase.</u>
