OBSERVATIONS: Site visit conducted as a part of Wake County's E&SC Complaint investigation process:

*Town of Rolesville received a complaint that was forwarded to Wake County for a follow up inspection. Site inspection was only a partial inspection of the southern perimeter of the site.

1) Stabilization:

- -Apply anchored temporary ground cover to the following denuded areas within 14 days: Swales in rear of lots 1-15, slope below walking trail next to SCM 1, internal an top of banks of SCM 1, slope above SCM 2, perimeter behind lots 256-275(where needed), and any other denuded/inactive areas throughout site.
- -Apply natural mulch (leaf litter or pine straw) to disturbed soils beyond outer side of perimeter silt fence on downstream side of stream crossing to left of lot 255 and left side of stream

2) Silt Fence/Silt Fence Outlets:

- -Install perimeter lot silt fence/outlets around lots, where missing, throughout site.
- -Remove sediment from silt fence where it has reached/exceeded below retaining wall in rear of lots 256-275, where necessary
- -Remove sediment and clogged stone from silt fence outlet on downstream side of stream crossing to left of lot 255 and left side of stream.

3) Streets:

-Sweep/clean sediment tracking from paved streets throughout site, where necessary.
