- 4. Working Hours:
 - a. Normal working hours are 7am to 7pm on weekdays and 8am-6pm on weekends.
- 5. Construction Coordination Meetings:
 - a. Due to the short duration of this project, monthly meetings will not be held.
- 6. Payment Procedures:
 - a. Pay applications and payments will be handled between the CAPCON and Crosland Southeast.
- 7. Requests for Information, Field Orders, Change Orders:
 - a. All RFIs, FOs and COs are official documents requiring signatures.
- 8. Traffic Control
