Charles Flournoy, 10 Watkins Farm Road, Rolesville, NC

Mr. Flournoy was present to report on the recent gas leak in his subdivision which was caused by nearby construction. Flournoy reported that he had to evacuate his residence and made the point that the Watkins Farm Subdivision only has one ingress/egress which was highlighted by the leak and resulting responding vehicles. Lastly, Flournoy pointed out the damage to the existing sidewalk caused by the construction. Mr. Flournoy was assured that the sidewalk would be repaired.

Mayor Currin asked Town Manager Kelly Arnold to schedule future discussion on "one-way" neighborhoods.

Inquiries were made as to if the developer called 811 – Call Before You Dig, ahead of the construction.

Mr. Burnham reported that Broughton Development would follow and touched on the project(s) schedule moving forward.

Town Manager Kelly Arnold pledged to forward a copy of the agreement to the board members with the new site plan attached.
