4. Commissioner Alston – Veterans

- Spoke with retired Captain who is the Navy Jr. ROTC Area 6 Manager to inquire if Rolesville High School had communicated with him regarding and ROTC program at the school. The answer was no. Commissioner Alston to visit the school to find out what the holdup is.
- Winston Salem Veterans Administration Regional Office had the Veterans Benefit Live event in High Point on July 20th – 22nd. The event was held to address the PACT act.
- Retired Master Sgt. Jerry Mangum held the second Veterans' Fellowship Breakfast on July 26th. The event was held at 9:30 a.m. and Veterans and spouses discussed issues with navigating the Veterans Administration. The next meeting is being called Operations Veterans Real Talk and will be held at Wake Chapel Church, 3800 Tar Heel Club Road, Raleigh on November 18th at 11:00 a.m. The topic will be Veterans not receiving healthcare in a timely manner as promised.

- Construction is moving quickly on Public Works facility. The project is ahead of schedule.
- Public Works facility framing is done, and the mezzanine has been poured.
- · A reported sink hole has been repaired.
- Offer extended to internal candidate for Operations Coordinator position.

Parks & Recreation

- Rolesville 4th event was a success.
- Parks & Recreation Advisory Board meeting was held July 26th at the Main Street Park.

Capital Projects

G. NEW BUSINESS

Budget Amendment for Fiscal Year 2023-24
 Planning Director Meredith Gruber, Economic Development Manager Mical McFarland and Assistant Town Manager Eric Marsh were present to answer questions on the three budget amendment items:

Moved by Commissioner Sneed to approve the ordinance to amend the 2023/2024 fiscal year Budget Ordinance dated August 1, 2023; seconded by Commissioner Medley. Commissioner Sutton recused herself from voting which was approved by the Town Board. Motion to approve carried by unanimous vote.

 Legislative Hearing: ANX23-03 – Wallbrook Landco, S. Main Street. Planning Director Meredith Gruber provided a staff report on ANX23-03.

 Deputy Town Attorney Erin Catlett reminded the Town Board that it would need to go in to Closed Session for communication.
- 2. Communication from Town Manager
 - Next Town Board meeting is August 15th which will begin at 6:00 p.m. in order to bring back the Town Campus site plan in the work session which will follow a legislative hearing.
- 3. Communication from Town Board
 - Commissioner Sutton reminded everyone of the trip several Commissioners took to the Peace and Justice Memorial in Montgomery, Alabama back in December 2022. Wake County has the *Wake County Remembrance Coalition* which is working with Brian Stevenson (from the movie *Just Mercy*). Plans are to host the moving memorial to recognize the lynching of George Taylor just outside of Rolesville in 1918. Sutton is working on the committee trying to bring the mobile memorial. Commissioner Sutton stated her desire to bring additional information to the Town Board at a future Work Session.
 - Mayor Currin pitched the next Mayor's Show to be held on August 10th and will host Rolesville High School Football Coach Ranier Rackley and Alicia Cozack as guests.
