I have seen in other similar cases something like "the impact of this development will not have a significant effect on the existing traffic at this location and/or all practical Right – Of – Way improvements have already been installed or are currently planned to be installed. There are no additional practical Right- Of- Way improvements that would result from preforming a TIA for this development that are not already installed or planned to be installed. Therefore Rolesville will not require a TIA for this development at this time but reserve the right to reanalyze prior to issuing construction permits if existing and/or proposed Right – Of – Way improvements were to significantly change prior to the start of construction" you can probably word it a little better but I

have run into similar situations where all the DOT improvements are there and there are no real additional improvement that would be feasible.

Sorry for the delay—I've been pondering this one. Rolesville's LDO states TIAs are required when there are more than 50 peak hour trips and/or more than 500 daily trips generated. The LDO also states the Land Development Administrator (LDA) may waive the requirement for a TIA upon determining that a TIA is not necessary to determine needed road improvements, that adequate capacity exists to serve the proposed development, and that no unsafe or hazardous conditions will be created by the development as proposed. This decision shall be documented with specific reasoning provided by the LDA. Based on the location of the proposed project and road improvements going on now, I am inclined to waive the requirement as long as I have reasonable documentation to put on file. Any thoughts on the text highlighted in yellow?

Parker,

To be conservative we usually just use the peak trip data times the 12 hr we are open. So 480 cars for a peak daily or 960 trips. Also note that when we run a true TIA for our sites impact on the adjacent roadway it is going to show a 70% reduction in trips generated. So for our access point we will increase the trips but for the roadway we are utilizing the existing vehicles and don't generate many actual new trips so our impact to the intersections north and south is significantly reduced; typical TIA will reduce by 70% but I would argue its probably closer to 90%; people don't drive across town just to wash their car we are a convenance for the existing traffic. If you need something more detailed let me know or if we are close to a threshold I can put together some more exact numbers specific to this site and what are expected sales are.
