Planning & Zoning

Planning Staff

6. Provide table/note that detail each lot by: Lot Number / Lot Address / Maximum Impervious Coverage permitted for Each Lot.

Provide a table/note of the Linear Length (and ROW width) of all new public right-of-ways being dedicated to the Town (or NCDOT). This is for State Powell Bill purposes.

McAdams Response: This has been added to the cover sheet.

8. STREETLIGHTS – IF new streetlights are installed in Town public right-of-way- provide Lighting Plan exhibit that clearly indicates the number of poles in This Plat. Staff will then INVOICE for the one-time \$650/pole fee, which must be paid prior to Town signature/approval of plat.

McAdams Response: Please see street light exhibit included with submittal materials.

Record the noted Retaining Wall Access Easement which presently has "blank" BM/PG – "blanks" cannot be recorded. They are either newly created via this Plat, or they are referenced from already Recorded plat.

McAdams Response: Noted. That plat will be recorded prior to this one and will be filled in prior to recordation of this plat.

10. In General – Make all the revisions/changes per the Staff Comment made to/on FSP-25-04 for Phase 4, received on 3-12-25.


McAdams Response: Noted.


