**SUBJECT:** Hills at Harris Creek 3<sup>rd</sup> Submittal CID-24-07 Comment Response

In response to review comments provided on 03/09/2025, we are providing the following comment responses:

Planning and Zoning – Planning Staff and WithersRavenel

1. Continue to Provide a Written Response to ALL comments

SREG RESPONSE: Written responses to all comments are included within this submittal. Please note that Strongrock Engineering Group Drawings have incorporated past staff comments at the PSP level including staff commitments regarding code compliance and interpretation.

2. Continue to add revision dates to all submittal materials.

SREG RESPONSE: Revision dates have been added to all submitted materials.

3. <u>AS6 (Running Trail/Course)</u> – Per the outcome of the Review on PSP 24-03 – this is to be a Private amenity, and CID plans are to include construction specifications on that – Add/revise or confirm these plans include construction details for this item.

SREG RESPONSE: The running trail will be a 10' wide paved asphalt path that uses the Town of Rolesville Standard Greenway Section, see Sheet D1.0 for the section details.

#### Engineering – Jacque Thompson

#### Parks & Recreation – Eddie Henderson

No comments were received; there have been Staff absences late in November; Parks will review the next submittal for compliance.

1. Greenway next to SCM#8/Lot 210 - The Town strongly prefers Greenway going around SCM#8 as shown in Rezoning Concept plan. Revise, or arrange meeting with Staff to explain why that cannot occur.

## SREG RESPONSE: SCM 6 has been redesigned, and the endpoint of the greenway is directly in line with the current route of the proposed greenway, see Sheet 6.0 and 6.6

2. Bicycle Lane - Revise to show bike lane running along entire Mitchell Mill road frontage of property.



# SREG RESPONSE: The bike lane configuration on Mitchell Mill Road is currently being designed and coordinated with NCDOT. This design will be included on future PSP and CD submittals, thank you.

3. Revise Greenway typical section to include this language: "Greenways shall be constructed with either asphalt or concrete pavement. When using asphalt, a 2-inch minimum asphalt course, Type S9.5B, with a 6-inch aggregate base course shall be provided. When concrete is used, a 4-inch minimum Portland cement concrete (PCC) with a 6-inch aggregate base course shall be provided. Regardless of the material, geotextile stabilization fabric shall be placed under the compacted aggregate base course (ABC) the entire length and width of the Greenway."
