

Request for Proposal Automatic Security Gate for Mill Bridge Nature Park Issued: June 12th, 2023

Description

The Town of Rolesville is seeking proposals from established vendors who have been in the business of automatic gate installation and security services.

Background

The Town seeks information and cost estimates regarding the installation of automatic arm gates for the entrance of Mill Bridge Nature Park, located at 425 Nature Park Drive, Wake Forest, NC 27587. Staff currently must open and close the gates daily; the Town would like to save time and resources while maintaining security by installing an automatic gate.

The gates must be able to:

- Be monitored and controlled remotely
- Control traffic in both lanes of travel

Scope of Services

- <u>Automatic Gate Installation and Monitoring</u>
 - 1. Gate Installation
 - 2. Gate Monitoring
- Other Requirements
 - 1. Vendor must certify that all employees of the vendor who work in Town buildings have passed a background check and maintain a clean criminal record.
 - 2. Any damage caused by the vendor or employees will be repaired by the vendor at their expense.
 - 3. Vendor is expected to comply with federal, state, and local laws and regulations.
 - 4. Vendor is expected to follow best practices to maintain confidentiality between vendor and client.

- The Town reserves the right to reject any or all proposals and to waive any informalities as may be permitted by law.
- The Town reserves the right to request oral interviews or request additional information from any or all vendors.
- The Town reserves the right to award a contract based on proposals received without further discussion or negotiation.

All proposals shall be signed by an authorized officer or employee of the submitting organization. The name of the company, contract person, telephone number, fax number, and address shall be included.

The RFP does not commit the Town to award, nor does it commit the Town to pay any cost incurred in the submission of a proposal, or in making necessary studies or designs for the preparation thereof, nor procure or contract for service or supplies. Further, no reimbursable cost may be incurred in anticipation of a contract or award.
