PUBLIC HEARING (LEGISLATIVE) ON CASE MA18-01: CHANDLER'S RIDGE

Introduction by Staff

Planning Director Danny Johnson introduced the property under consideration for a zoning map amendment from Residential 1 District (R1) to Residential 2 District (R2).

Motion carried by unanimous vote.

PUBLIC HEARING (LEGISLATIVE) ON CASE MA18-02: THALES ACADEMY

Introduction by Staff

Planning Director Danny Johnson provided an introduction, overview and staff recommendations on the property under consideration.

Mayor Eagles opened the public hearing on Case SUP17-02 at 7:28 p.m.

Comments from Applicant

Applicant's Attorney Beth Trahos with Nelson Mullins explained the choice of zoning being requested as it is consistent with adjacent property.

Michael Roach, Thales Academy, LLC and WFINV, LLC, 8151 Town Drive, Raleigh, NC, explained the timeline on the land purchases in the area of the property under application. Additional land will remain residential with no plans for development at this time.

Jessica Rosse with Kimley-Horn, Senior RE Marketing Analyst reviewed the absorption study included in the agenda packet.

Commissioner Sutton requested that future staff memos contain example motions for and against cases that come before the Board as was done in the past.

PUBLIC HEARING (QUASI-JUDICIAL) ON CASE SUP18-01: THALES ACADEMY SPECIAL USE PERMIT Mayor Eagles opened the public hearing on Case SUP18-01 at 7:40 p.m.

Town Attorney David York read the following statement: Quasi-judicial hearings have characteristics similar to court proceedings. Quasi-judicial decisions must be based only on evidence presented at the hearing and site visits by the board if any. Witnesses must testify under oath or affirmation. Parties have the right to cross examine the witnesses and there is a right to present rebuttal evidence. The evidence provided by a witness must be competent material. North Carolina State law prohibits a person from giving opinions about scientific, technical or other specialized subjects, unless the person, from knowledge, skills, experience, training or education is in fact an expert on the subject. A person wanting to give an opinion as an expert must first state his or her qualifications to be an expert on the subject. State law specifically prohibits opinions of the use of property in a particular way would affect the value of other properties or opinions that increase in vehicular traffic resulting from a proposed development would pose a danger to the public safety unless the witness is an expert on the subject.

Attorney York queried the board members as to their predisposition, prior discussion with opponents, or inability to make a decision based solely on evidence presented. Hearing satisfactory answers from all board members, the Town Clerk swore those persons in wishing to provide testimony.

Planning Director Danny Johnson provided an introduction of the case under consideration.

Applicant's Attorney Beth Trahos, Nelson Mullins, introduced herself and gave evidence as to her ability to be a witness.

Ross Massey, Civil Engineer with Stewart Engineering, Inc. spoke regarding the site organization and proposed development plan's consistency with the town's comprehensive plan.

Travis Fluitt, Kimley-Horn Traffic Engineer spoke regarding the traffic impact report provided with the application for special use permit.

The Board discussed additional requirements for 2nd exit onto Highway 98/Wait Avenue when the property comes before the board for site plan approval (Phase 6) which will amend the special use permit.

Tom Hester, MAI, CCIM, appraiser with Hester & Company, 228 Fayetteville Street, Suite 200, Raleigh, NC 27601, provided testimony regarding adjacent property value impact.

Attorney Trahos provided testimony as to the Ordinance Findings of Fact requirements being met by the special use permit proposal.

Lynn Peed with PPM, Manager of Granite Ridge Apartments and Granite Falls communities asked that the allocation for the construction of Granite Falls Boulevard remain in the budget.

Veronica Dews, Site Property Manager for The Grande at Granite Falls asked for assurance that Granite Falls Boulevard would be built no later than December 15, 2018.

Shane Maxwell, 2808 Pluton Place, came to express his complaint that yard waste is only picked up bi-weekly (lives in neighborhood on Rogers Road) and states that it is critical that the yard waste schedule be addressed ahead of the mid-year proposed absorption by the town.

Moved by Mayor Pro Tem Currin to approve the resolution to support the changing of the solid waste fee as a lump sum on the property bill beginning in July 1, 2019; seconded by Commissioner Sutton. Motion carried by unanimous vote.

Moved by Mayor Pro Tem Currin to approve the Findings of Facts and Conclusion of Law Order for the Special Use Permit for Elizabeth Heights for which the Board conducted an evidence hearing on May 1, 2018; seconded by Commissioner Wilson. Motion carried by unanimous vote.

CONSIDERATION OF CASE S18-01: ELIZABETH HEIGHTS PRELIMNARY SUBDIVISION PLAT

Planning Director Danny Johnson introduced Case S18-01 Elizabeth Heights Preliminary Subdivision Plat.

Moved by Mayor Pro Tem Currin to approve CASE S18-01 to approve the subdivision plat; seconded by Commissioner Sutton. Motion carried by unanimous vote.

CONSIDERATION OF SPECIAL EVENT APPLICATION – 4TH OF JULY

Town Clerk Robin Peyton presented the 4th of July Special Event Application requiring a motion to waive Town Code 113.5 which pertains to alcohol on Town property.

Moved by Commissioner Medley to recuse Commissioner Vilga from voting as he is President of the 4th of July Committee; seconded by Commissioner Wilson. Motion carried.

Moved by Commissioner Sutton to approve the 4th of July Special Event Application, waiving Town Code 113.5 for the duration of the event; seconded by Commissioner Wilson. Motion carried by unanimous vote.

SPECIAL EVENT ORDINANCE REVISION

Town Clerk Robin Peyton provided a recap of the Special Event Ordinance Revision introduced in the Board's May 15th Work Session.

Moved by Mayor Pro Tem Currin to approve TA18-01 amendments to Town Code Article 11, Chapter 113; seconded by Commissioner Wilson. Motion carried by unanimous vote.

Commissioner Sutton inquired regarding unused funding being rolled over in the Utility Customer Assistance Program Interlocal Agreement.

Moved by Commissioner Sutton to approve the Interlocal Agreement for the Utility Customer Assistance Program; seconded by Commissioner Vilga. Motion carried by unanimous vote.
