Mayor Eagles announced that the public hearing would be continued until October 1, 2019 at the request of the developer.

For the benefit of the public present, Town Manager Kelly Arnold read aloud the letter from the developer this date, requesting the hearings be continued to October 1, 2019 and reported that the pending continuations were posted on the Town's website.

Following a short recess to allow those present for the continued public hearings to exit, the board returned to open session at 7:40 p.m.

Introduction by Staff

Planning Director Danny Johnson provided information for consideration in the petition for rezoning. A neighborhood meeting was held July 18th with eighteen persons in attendance and the Town Board was provided a summary of comments made. The Planning Board reviewed the Case and voted unanimously to recommend the Town Board approve as the amendment is consistent with the Town of Rolesville Comprehensive Plan.

Mark Phillips with Pabst Design Group, engineering firm for the project, made known is presence to answer any questions from members of the board and showed a draft rendering of the building proposed for future site plan approval should the rezoning be approved.

Close Public Hearing

There being no one remaining to speak, Mayor Eagles closed the public hearing on Case MA19-04 at 7:54 p.m.

Moved by Commissioner Wilson to approve Resolution 2019-R-13 Board of Commissioners Statement of Consistency in Case MA19-04 as presented; seconded by Commissioner Sutton. Motion carried by unanimous vote. Resolution incorporated herein by reference.

Barrington Land Exchange

Finance Officer Amy Stevens provided information on the exchange of property involved in the board's prior approval of accepting a \$250,000 fee-in-lieu provided by the developer for the building of a portion of Granite Falls Boulevard instead of building the road. The fee-in-lieu was satisfied by the board approving the acceptance of a 6 acre tract of land. Both actions were memorialized in the Barrington Subdivision development agreement. Ownership of the development has changed and the new owner is proposing the building of the portion of Granite Falls Boulevard in exchange for acquiring the 6 acre tract of land. As the value of the land in the exchange is comparable to the value of the completed roadway, North Carolina General Statutes are met. Easement acquisition(s) are included as a condition of the completed exchange.

Moved by Commissioner Wilson to adopt Resolution 2019-R-14: Resolution Authorizing Exchange of Property contingent upon the approval of the Barrington Subdivision and Southtown Professional Center development agreement amendment #1; seconded by Commissioner Vilga. Motion carried by unanimous vote.

Finance Officer Amy Stevens provided information for consideration in the public hearing for the Barrington Development Agreement Amendment #1.

Mayor Eagles opened the public hearing on the Barrington Development Agreement Amendment #1 at 8:14 p.m.

Avery Morrow, 1027 Granite Ridge, Rolesville, NC

Mr. Morrow expressed his concern for residents of Grand Rock Way in that the completion of the road would create a cut-through street from Burlington Mills Road to avoid driving on Main Street. In response it was reported that Granite Falls Boulevard was designed to be a thoroughfare Street which will assist the residents in the Grand Rock Way area.

Michael Grueneich, 206 Brown Circle, Rolesville, NC

Inquired as to the timeline for completion of the road to which was responded approximately two to three years.

- The department is currently reviewing its policies and procedures to ensure best practices are being incorporated with the assistance of the North Carolina League of Municipalities.
- August 29th, interviews were held for the additional officer position approved by the board.
