#### A. CALL TO ORDER

- 4. Board Liaison Reports
  - Mayor Pro Tem Medley Planning Board
    - Reported on the list of Land Development Ordinance (LDO) items requiring further discussion, i.e., greenways, setback requirements, regulation of construction trailers and food trucks, more specific regulation of tree planting and removal.
  - Commissioner Sutton Economic Development
    - Voiced her concern that the town action and proposed budget are too lean concerning continuing economic development.
    - The Rolesville Chamber is promoting a Cash Mob on May 5<sup>th</sup> at 12:00 p.m. to support local businesses. This Cash Mob will be for *What's Cooking*, the food truck located in the parking lot next to the Veterans Memorial.
    - A ribbon cutting for new attorney Michael Paul will take place at his new office location at 511
       S. Main Street on May 6<sup>th</sup> at 3:00 p.m.
  - Commissioner Vilga Parks & Recreation Advisory Board
    - The April Parks & Recreation Advisory Board meeting was cancelled due to lack of a guorum.
    - Asked that everyone get out and support the Rolesville High School Football team as it will be
      playing in the state championship game.
  - Commissioner Wilson Public Safety
    - Attended a retirement party for long-time bookkeeper for the Rolesville Rural Volunteer Fire Department, Ms. Lilly. Ms. Lilly's position at the fire department has been filled by her sister.

#### Comments from Public in Opposition

Liz May, 1416 Carrie May Lane

Ms. May alleged the developer is circumventing the conditional zoning process as outlined in the town's Unified Development Ordinance (UDO). Specifically, Ms. May declared the applicant's map does not show easements, rights-of-way, intended uses, topography, traffic patterns, parking spaces, number and location of units and location of trees.

Ms. May asked the board to either continue the hearing pending the applicant submission of required information; or deny the petition outright.

Commissioner Wilson asked Attorney Neill about the accusations made by Ms. May in that the town is not following property protocol in the case under hearing.

4. Legislative Hearing: UDO MA20-04 Rezoning 2005 and 2033 Wait Avenue.

Following the staff report given by Planner Julie Spriggs, Attorney Neill requested a short recess so that he may review the application with staff in order to provide appropriate guidance in lieu of accusations made under public comments in the annexation hearing. The board recessed at 8:15 p.m.

The town board reconvened at 8:35 p.m. Following their review, staff and attorney recommended continuing both public hearings to allow for further comparison of application against current ordinances.

Mayor Currin opened the public hearing on Case UDO MA20-04 at 8:39 p.m. and at such time it was moved by Commissioner Wilson that both public hearings be continued to the Town Board's July 8<sup>th</sup> Regular Meeting. Motion was seconded by Mayor Pro Tem Medley and carried by unanimous vote.

5. Public Hearing: Financing Agreement for Municipal Complex. Town Manager Kelly Arnold introduced the agreement under consideration. The agreement is with Southern Bank and the board was assured approval of the agreement would not constitute agreement of the purchase of the 17-acre property known as Woodlief. The Local Government Commission requires submission of such an agreement by May 5<sup>th</sup> in order to approve the financing.

Mayor Currin opened the public hearing on the Financing Agreement for Municipal Complex at 8:48 p.m.

Moved by Commissioner Wilson to approve Resolution 2021-R-20: Resolution approving financing terms with Southern Bank; seconded by Commissioner Vilga. Motion carried by unanimous vote.

Cole-Jenest & Stone provided due-diligence testing on the property under consideration for financing with Southern Bank and intended for a new Municipal Complex. Representatives provided the Town Board with findings thus far.

The Town Board requested the information be posted on the Town of Rolesville website for public review.

Public Hearing: Proposed Budget for Fiscal Year 2021-22.
 Following previous review by the Town Board, the proposed budget was presented again under the required public hearing in order to provide for public comment.

Finance Director Amy Stevens provided a brief presentation of the previously reviewed budget noting the title change from Recreation Superintendent to Project and Facilities Coordinator for the Parks & Recreation Department. Town Manager Kelly Arnold explained that a Superintendent position will undoubtedly be needed in the future for Parks & Recreation and that the new title for the currently proposed position will come with a lower pay grade and will supervise the custodial staff but not be an assistant position to the Parks & Recreation Director.

Mayor Currin opened the public hearing on the proposed budget for FY2021-2022 at 9:59 p.m.
