# A. CALL TO ORDER

Mayor Currin called the Regular Town Board Meeting to order at 7:00 p.m.

Pledge of Allegiance

Members of Boy Scout Troop #141 were present and led the Pledge of Allegiance.

- Developmental Disability Awareness Month 3. Proclamations Mayor Currin read the Proclamation aloud.
- 4. Review of Agenda by the Board and Addition/Changes of Items of New Business to the Agenda for Consideration.

Moved by Commissioner Sutton to approve the agenda; seconded by Mayor Pro Tem Vilga. Motion to approve agenda carried by unanimous vote.

### B. CONSENT AGENDA

Moved by Mayor Pro Tem Vilga to approve the Consent Agenda as presented and consisting of the following:

# C. BOARD LIAISON REPORTS

- 1. Mayor Pro Tem Vilga Parks & Recreation Advisory Board
  - The PARAB met on 2/22. Officers were elected.

- Reviewed a greenway and bike lane requirement on a proposed Averette Road and Jones Dairy development that is upcoming.
- Reviewed park banners to put in parks to update what was previously hanging.
- Talked about thirty-three potential Capital Improvements Projects (CIP).
- Garrett Soney, Parks & Recreation Athletic Coordinator left, and Parks & Recreation Director J.G. Ferguson is covering for him.
- Arbor Day in Rolesville will be recognized with an event at Shelter D in Main Street Park on March 18<sup>th</sup> at 11:00 a.m.

# 2. Commissioner Sutton – Economic Development

- Economic team present this evening.
- Economic Development Strategic Plan becoming dated. Last updated 2018. Time to update as consultants have recommended updating every five years.
- During a recent drive around Rolesville, Commissioner Sutton noted that Carlton Pointe has eighteen frames erected for future homes near the ABC store.
- Also toured Franklin Street and Holding Village in Wake Forest. Encouraged fellow board members to get out and see what is happening in developments.
- Cobblestone is making leasing progress and should be fully leased by the time the
  project is complete to potentially include a large regional restaurant. Also working on
  Nescalito Mexican (Durham) and letters of intent from additional restaurants and
  interest from multiple medical users, nail/hair salon and spa and regional coffee group.

# 3. Commissioner Medley – Planning Board

- Two topics were discussed at the last Planning Board meeting.— cluster development questions (lot sizes, setbacks) and notifications distance. Planning Board recommending the distance be increased to five hundred feet.
- · Affordable housing meeting tomorrow.

### 4. Commissioner Alston - Veterans

- 2/22 met with NC Heroes fund board member.
- Memorial Day coming up in two months.
- Commissioner Alston spoke about the Memorial Mile signs the Town is offering as well as t-shirts.
- Dept of Veterans Affairs announced that March is Multiple Sclerosis Centers of Excellence awareness month.

# 5. Commissioner Sneed – Public Safety

- Rolesville Rural Fire Department held a brief meeting was held on 2/13.
- Department is almost fully staffed. Twenty-eight volunteers and thirteen paid staff. Still seeking volunteers.
- 21<sup>st</sup> is the next meeting which will have an update on unification.

### 3. Terri Simmons, Rolesville Chamber of Commerce

- The Chamber Board is reviewing resumes to potentially fill the Executive Director position.
- Ms. Simmons shared updated statistics including membership growth to 173 members with twenty-one new members.
