NORTH CAROLINA NON-WARRANTY DEED

THIS DEED, made the 31st day of December 2005, by Robert M. Duke and wife, Marsha H. Duke, Ronald E. Duke and wife, Dianne Holmes Duke, and Roger Duke, unmarried (hereinafter referred to as "Grantors") to Brother's Forty-Six, LLC, (hereinafter referred to as "Grantee") a North Carolina limited liability company having an address of 4558-B Capital Boulevard, Suite 129, Raleigh, NC 27604.

WITNESSETH:

WHEREFORE, Grantors have and by these presents do grant, bargain, sell and convey that parcel of land (hereinafter "the Property") located in Wake Forest Township, Wake County, North Carolina and fully described as follows:

BEGINNING at an iron pipe in the center line of Highway 2051, said point being the northwest corner of the tract herein described; runs thence along and across said highway South 85 degrees 10 minutes East 1,317 feet to an iron pipe; thence with the Wall land line South 3 degrees 10 minutes West 645 feet to an iron pipe; thence with the Wiggins land line South 3 degrees 40 minutes West 601 feet to an iron pipe; thence with the L.T. Wilson land line North 87 degrees 40 minutes West 2,058 feet to an iron pipe; thence with the Rogers land line North 10 degrees 30 minutes East 698 feet to an iron pipe; thence continuing with the Rogers land line North 84 degrees 20 minutes East 629 feet to an axle; thence continuing with the Rogers land line North 4 degrees 30 minutes East 525 feet to the center line of Highway 2051, the point and place of beginning, containing approximately 47.41 acres, and being designated as Tract No. 3 of the W.H. Marshall Estate, Rolesville, Wake County, North Carolina, according to a survey by C.W. Russum, Registered Land

Surveyor, dated July 1961 and recorded in Book of Maps 1961, Page 97, Wake County Registry. This being the same property conveyed to G.R. Watkins in an instrument dated March 30, 1962 and recorded in Deed Book 1500, Page 169, Wake County Registry.

SAVE AND EXCEPT the following property:

BEGINNING at a point in the center of State Road #2051, said point located .3 miles northwesterly from U.S Highway No. 401, thence along the center of said State Road #2051 the following courses and distances: North 40 degrees 58 minutes West 234.35 feet to a point; North 43 degrees 13 minutes West 100 feet to a point; North 49 degrees 56 minutes West 100 feet to a point; and North 60 degrees 32 minutes West 100 feet to a point in the center of said road; thence North 4 degrees 50 minutes East 31.82 feet to an iron pipe in the northerly right of way line of said State Road #2051, said stake being the southerly line of the Wall property; thence along the southerly line of the Wall property South 85 degrees 10 minutes East 406.23 feet to an iron pipe, corner of the said Wall property; thence along the Westerly line of said Wall property South 3 degrees 27 minutes West 361.61 feet to the point of beginning, and containing 1.62 acres as shown by a map of survey entitled "Property of Willard T. Parks" made by J. Fred Davis, Jr., R.S., July 11, 1967. This being the same property conveyed to Willard Parks and wife, Barbara Freeman Parks in an instrument dated August 11, 1967 and recorded in Deed Book 1781, Page 10, Wake County Registry.
